
South Africa - Weather


- Portions of Free State and neighboring areas will receive enough rain to bolster soil moisture in the coming days
- Rain amounts will be too light to completely fix the moisture deficits and additional precipitation wil still be needed
- o Winter wheat prospects will likely improve in several areas and some of the crop will likely be brought out of dormancy
- The lack of significant follow-up rain during the second week of the outlook may slow growth in mos
- Western Cape will remain dry or critically dry during the next two weeks
- o The main winter wheat areas also need a good amount of rain to support better growth prospects
- Temperatures will trend near to slightly above normal through next Wednesday
- o Highs will be in the 70s and 80s Fahrenheit most often






United States of America - Weather


U.S. MIDWEST: A powerful storm system will bring heavy snow to parts of the far northwestern Corn Belt Thursday into Saturday along with frost and freezing temperatures to western, central, and northern parts of the western Corn Belt with some damage to immature corn likely to result from the cold. O Freezes will expand from the far northwestern Corn Belt Thursday morning to most areas from the eastern Dakotas to northeastern Kansas through south-central and northern lowa and northwestern Wisconsin by this weekend.

U.S. DELTA AND SOUTHEAST: The Delta and the Southeast will see mostly favorable conditions for crop maturation and harvesting through the next two weeks with occasional rounds of showers that should not bring enough rain to cause serious disruptions to fieldwork or cause significant quality declines to crops. o A few light showers will occur into Thursday with rain better organized Friday from the northern Delta into Alabama where most areas will see 0.05-0.60" of rain and locally more with little rain elsewhere in the Southeast.




South America - Weather


BRAZIL: Many areas are still expected to see an overall improving trend for planting through the next two weeks, but coverage of significant rain will not be widespread and some areas will be left in need of greater rain to improve soil moisture.


o The driest areas through Tuesday will extend from central and northern Goias to Bahia and central and northern Minas Gerais where most areas will be dry with some rain in coastal areas. ARGENTINA: Much of Argentina will see little rain of significance through Thursday leaving many areas in need of rain to improve conditions for summer crop planting and winter wheat development.

o An exception will occur from northern into eastern Buenos Aires where 0.30-1.0" of rain and locally more will fall.






Europe, New Zealand and Australia - Weather


EUROPE: Rounds of precipitation will occur from the U.K., France through north Italy, Germany, the Czech Republic, Austria into Poland as well as Scandinavia this week. The greatest moisture will occur from the U.K. into the Netherlands and Scandinavia where totals will range from 0.75 to 1.50 inches and local totals exceeding 2.00 inches.

AUSTRALIA: Rainfall will increase over east New South Wales and east Queensland Friday into Saturday. The greatest precipitation will occur Friday. However, greater rainfall will still be needed in east-central Australia and beneficial moisture will be limited to coastal areas back into parts of Darling Downs, Queensland and a few interior northeast New South Wales locations. Erratic showers will evolve prior to the greatest rainfall Thursday and linger into the weekend. Beneficial moisture will impact a small region of eastern crop production areas of northeast New South Wales and Queensland through the coast. Any moisture is welcome, but a greater soaking will still be needed to improve long term dryness in many locations
