BDLive - The JSE recorded its first positive close in four sessions on Monday, rising 2%, while the rand made limited gains on the back of a softer dollar, breaking a five-day losing streak. Despite the day's gains, the rand was still trading around R16.30 to the dollar, the weakest level since October 2020, as global growth fears continue to plague markets.

Emerging market currencies have been on the back foot as recession fears, a hawkish US Federal Reserve, and rising interest rates in major economies weigh on risk-sensitive markets, said TreasuryONE currency strategist Andre Cilliers.

At 6.12pm, the rand had strengthened 0.23% to R16.3370/\$, , according to Infront data. It had strengthened 0.25% to R17.0343/€, while it was little changed at R19.7761/£. The euro was steady at \$1.0427.

BDLive - Bengaluru — Gold inched higher in choppy trade on Monday, as weakness in Treasury yields kept prices above the \$1,800 mark and marginally outweighed pressure stemming from elevated US dollar levels.

Spot gold was up 0.1% at \$1,811.99 per ounce by 5.19am. US gold futures rose 0.6% to \$1,812.10

Bullion prices hit a five-month low of \$1,783.50 on Friday, but recovered to end the session nearly steady.

Once again, we saw buyers support gold with its break below \$1,800 on Friday, and with US yields continuing to retrace, it allows the potential for old to rise over the near term," City Index senior market analyst Matt Simpson said.
