





South Africa - Weather


SOUTH AFRICA: Soil moisture is rated almost ideally across the nation's summer grain, oilseed, cotton and soft commodity crop production areas. Rain will fall routinely in the next two weeks with some short term breaks that will allow sunshine to stimulate faster crop development. Production potentials remain high in most of the nation. Rain is expected in nearly all summer crop areas from Free State, North West and eastern parts of Eastern Cape into Limpopo, Mpumalanga and Natal through the end of next week o Moisture totals will vary from 0.80 to 2.50 inches with local totals of up to and possible greater than 4.00 inches Mortheastern Limpopo, western Free States, western North West and eastern parts of Northern Cape will receive the lightest rain • Rain intensity and frequency will decrease during the January 7-13 period with moisture totals during that week varying from 0.30 to 1.50 inches with a few amounts getting over 2.00 inches.




United States of America - Weather


U.S. MIDWEST: Snow fell Thursday from east-central and southeastern South Dakota and northeastern Nebraska to central Minnesota and northwestern Wisconsin with a light wintry mix of precipitation surrounding the region while most other areas were warmer and dry. Outside of precipitation events into Saturday and Monday into Tuesday, the Midwest will see a quiet weather pattern through much of the next two weeks.

. U.S. DELTA: Rain returned to the Delta Thursday into this morning while the Southeast was mostly dry Two rounds of widespread and significant rain will fall on the Delta and the Southeast today through Wednesday leaving many areas with saturated soils while some local flooding is likely as well.






South America - Weather


BRAZIL: An area of showers and thunderstorms brought rain to many areas Thursday from central and south-central Goias and east-central Mato Grosso do Sul to central and southern Minas Gerais into nearby Sao Paulo with central and southeastern Mato Grosso seeing rain as well. Much of Brazil will see regular rounds of rain and favorable conditions for crop development through the next ten days to two weeks while Paraguay to Rio Grande do Sul will see one round of timely rain that should delay significant increases in crop stress with additional rain needed soon.

ARGENTINA: Argentina was mostly dry and warm Thursday with hot temperatures in a few southwestern locations. Nearly widespread rain expected this weekend is not likely to be great enougl to prevent overall increases in crop stress and declines in yield potentials as crop conditions should deteriorate before the rain and should decline again when the moisture is lost to evaporation next week.






Europe, New Zealand and Australia - Weather


EUROPE: Rain was mostly light Thursday and it was concentrated on France, northwestern Spain, northern Portugal, western parts of the United Kingdom and in Scandinavia. Moisture totals were mostly under 0.40 inch, although as much as 1.07 inches occurred in southwestern France. Rain is most likely in this first week of the outlook from Portugal and western Spain through western France into the North Sea region. o Rainfall will vary from 0.40 to 1.50 inches and locally greater amounts

AUSTRALIA: Rain is needed in Queensland where unirrigated summer crops are likely to be stressed by dryness and occasional warm temperatures. Not much relief is expected for a while. Drying has also been occurring in northern New South Wales, but its moisture profile is more favorable following flooding in the spring. Harvest progress in late season wheat, barley and canola has been great with the bulk of fieldwork already complete in many areas. Weather in the next ten days will be ideal for promoting field progress in any unharvested production region.
